NOTIFICATION

In exercise of powers conferred by sub-section (1) of section 24 of the Code of Criminal Procedure, 1973 read with sub-rule (2) of rule 7 of the Law Officers (Terms and Conditions) Rules, 1995, the State Government after consultation with the High Court of Sikkim is hereby pleased to appoint Shri Thinlay Dorjee Bhutia as Government Advocate-cum-Additional Public Prosecutor to conduct any prosecution, appeal or other proceedings on behalf of the State Government in the High Court of Sikkim for a period of 3(three) years with immediate effect. However, he is liable to be transferred to other courts in Sikkim. He shall report to the Additional Advocate General immediately.

He shall be paid consolidated fees of Rs.35,000/- (Rupees thirty five thousand), Retainer Fes of Rs.4,000/- (Rupees four thousand), Conveyance allowance of Rs.4,000/- (Rupees four thousand) and House rent of Rs.2500/- (Rupees two thousand five hundred) per month as prescribed under the Law Officers (Terms and Conditions) Rules, 1995.
