NOTIFICATION

Whereas, the State Government has vide Notification no 13/Home/2018 dated 10/03/2018, was pleased to regulate the sale of non-organic agricultural and horticultural commodities with an object to prevent risk of the health of human beings, animals and environment and deemed it expedient that such commodities shall be liable to be seized and disposed of;

Now therefore, with a view to achieve the above objectives, the State Government is hereby pleased to notify the following procedure for seizure and disposal of such commodities, namely:-

- Enforcement officers**
- 1 (1) The State Government shall designate such number of person(s) as it thinks fit to be Enforcement Officers to carry out the purpose for such seizure and disposal.
 - (2) The Enforcement Officers shall be officials of the Agriculture and/or Horticulture Departments not below the rank of Agriculture Development Officer/Horticulture Development Officer/Watershed Development Officer who shall be the seizing officer.

Procedure for seizure

- 2 The Enforcement officer, while preparing seizure of non-organic agricultural and horticultural commodities and documents shall follow the procedure specified as under, namely:-
 - (a) Seizure shall be made in Form I appended to this notification.
 - (b) The Enforcement officer shall obtain the signature of the person from whom seizure was made in the presence of two independent witnesses, duly signed in the Form I appended to this notification.
 - (c) The Enforcement officer, after seizure, shall report to the superior officer not below the rank of Director or equivalent or as the case may be
 - (d) Where there is a reason to believe that there is any act or commission in contravention to the Notification no 13/Home/2018 dated 10/03/2018 in respect to sell, stock, possess for commercial purpose, such non organic agricultural and horticultural commodities, shall be seized by the Enforcement officer.

**Procedure for disposal
of seized commodities**

3 The Enforcement officer shall dispose of the commodities seized in the following manner, namely:-

(a) That the Enforcement officer shall compost the seized commodities or dispose of in landfill at the Agricultural and Horticultural farms of the Departments.

(b) That every Enforcement officer shall forthwith report the disposal to the Superior Officer not below the rank of Director or equivalent or as the case may be in Form II appended to this notification.

**Enforcement Officer
not liable for damage**

4 The Enforcement Officers shall not be responsible for any loss or damage which may occur in respect of any commodity collected in furtherance to the seizure and no enforcement officer shall be responsible for any such loss or damage unless he causes such loss or damage wilfully, negligently, maliciously or fraudulently.

Effective Date

5 This notification shall come into force with effect from 31.03.2018


