Dear Sir,

The Forests, Environment and Wildlife Management Department has been providing decoration at Chintan Bhavan, Manan Bhavan etc, for programs of other departments through its Parks and Gardens establishment. This was possible due to availability of funds for this purpose from Environmental Cess. With the coming into force of Goods & Services Tax (GST) the Environment Cess has been abolished and the source of funding for the above mentioned purpose has also ended.

In view of this, Government has approved a proposal that Parks and Gardens Division of the FEWMD will only take up decoration of venues for official functions of National Days (Republic Day, Independence Day and Gandhi Jayanti) and State Day and for programs of other departments the concerned departments may themselves take care of decoration of their program venues from their own budget.
