The NIA requires the services of the experienced officials in the rank of Inspector, Sub Inspector and Assistant Sub Inspector on deputation basis at NIA Hqrs, New Delhi and at its branch offices Lucknow, Guwahati, Kolkata, Hyderabad, Mumbai, Kochi, Jammu and Raipur.

2. The NIA has advertised the posts of the above ranks in the Times of India & Hindustan Times newspaper dated 04.01.2017 and 'Employment News' dated 14-20 January, 2017 on deputation basis. The advertisement is also available on NIA website "www.nia.gov.in". The last date of receipt of the applications is 13.02.2017. The advertisement has also been sent to your office vide letter dated 23.12.2016.

3. The officials inducted on deputation will be governed by the standard terms and conditions of deputation as laid down in the Government of India DoP&T OM No 6/8/209-Estt. (Pay.II) dated 17th June, 2010 as amended from time to time. The initial term of deputation will be for 03 years extendable upto 07 years. The officials will get Special Incentive Allowance (SIA) @ 25% of basic pay and DA thereon in addition to other admissible allowances and subject to likely changes in the report of 7th CPC.
