The NIA requires the services of the experienced officials in the rank of Sub Inspector and Assistant Sub Inspector on deputation basis at NIA Hqrs, New Delhi and at its branch offices at Lucknow, Guwahati, Kolkata, Hyderabad, Mumbai, Kochi, Jammu and Raipur.

2. The NIA has advertised the above posts in the 'Employment News' dated 02-08 September, 2017 on deputation basis. The advertisement is also available on NIA website "www.nia.gov.in". The last date of receipt of the applications is 01 October, 2017. The advertisement has also been sent to your office vide letter dated 18.08.2017.

3. The officials inducted on deputation will be governed by the standard terms and conditions of deputation as laid down in the Government of India DoP&T OM No 6/8/209-Estt. (Pay.II) dated 17th June, 2010 as amended from time to time. The initial term of deputation will be for 03 years extendable upto 07 years. The officials will get Special Security Allowance (SSA) @ 20% of basic pay in addition to other admissible allowances.

(c) Experience of at least 02 years in the field of investigation of criminal cases, or intelligence work or operations or information technology cases or training in counter terrorism.
