Respected Sir,

Central Bureau of Investigation, being a predominantly deputationist organization, needs services of officers of other police organizations to fill vacancies under deputation quota at various levels. Inspectors are the cutting-edge level officers in CBI, who are entrusted with the investigation of complex and complicated cases. They form part of investigating teams constituted to investigate complicated and complex cases.

Deputation of officers from State Police in CBI not only enriches the deputationists and widens their horizons, but both the organizations also benefiting by sharing of best practices. Currently, there are 271 vacancies in the rank of Inspectors in CBI.

As per the prevailing R.Rs., the eligibility conditions are as follows :-

- (i) The officer must be a graduate from a recognized University.
- (ii) Officers in the State Police working at 'level of Inspectors' or working at the 'level of Sub-Inspectors' for a period of five years regular service are eligible to be inducted at the level of Inspectors in CBI on deputation;
- (iii) Inspector of Railway Protection Force or Inspector of Central Excise and Customs or Preventive Officers Grade.I or Examiner in Customs office or Income Tax Inspectors on regular basis under the Central Government or State Government or Central Public Sector Undertakings; and (b) Possessing at least five years Executive experience in vigilance or investigation or intelligence work in organizations.

Officials on deputation are entitled for a Special Incentive Allowance of 20% of the Basic Pay every month and also 13<sup>th</sup> month salary, as applicable from time to time.

I shall be highly grateful if you could give wide publicity to the matter and sponsor names with particulars of willing, suitable and eligible officers with impeccable integrity record for consideration of their deputation in CBI as Inspectors atleast for an initial period of 5 years which could be extended upto 10 years.
